Yes, Madam, Mr. President, the rule of law needs to be respected at all times.

Iran is fully entitled to the benefits of Article IV of the NPT.

Thank you!

And all citizens are fully entitled to the benefits of the right to a fair trial that Human Rights Treaties provide.

Where fundamental rights are at stake, applying double standards, to States or citizens, is not acceptable.

The right to a fair trial includes the right to be represented by independent counsel. This independence is elaborated in the Basic Principles on the Role of Lawyers, expressing the UN's standard for the protection of lawyers against interference by State- and other actors.

We congratulate President Rouhani for stating that "a lawyer should be immune from any prosecution for carrying out its professional duty, and the investigative authority for the lawyers' professional issues is the Bar Association". 1

Currently, a draft-Law providing rules for lawyers and their Bar Association is under review in Iran. This Draft deserves to be carefully tested against the provisions of the UN's Basic Principles and modified accordingly.²

Celebrating Iran's Day of the Lawyer (25 February) we sent President Rouhani a letter requesting him to review the detention of 7 Iranian Lawyers currently in prison for
